

**THE KENT COUNTY COUNCIL
(VARIOUS ROADS, MAIDSTONE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
ORDER 2012**

ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of their powers and under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act"), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Part III of Schedule 9 to the said Act of 1984, hereby makes the Order:

1. Save as provided in Articles 2 and 3 of this Order, no person, except upon the direction or with the permission of a police constable in uniform or a traffic warden cause any vehicle to wait in the length of road specified in the Schedule 1 and 2 to this Order.
2. Nothing, in Article 1 of this Order shall apply so as to prevent any person from causing any vehicle to wait in any of the lengths of road referred to in that Article for so long as may be necessary:-
 - a) to enable a person to board or alight from the vehicle
 - b) to enable goods to be loaded onto or unloaded from the vehicle
 - c) in connection with any building operation or demolition, adjacent to that road or length of road, the removal of any obstruction to traffic in that road or length of road, any maintenance, improvement or reconstruction of the length of road; or laying, erection, alteration or repair in or near the length of road of any sewer, or of any main, pipe or apparatus for the supply of gas, water, electricity or communications.
 - d) for police, a fire brigade, ambulance or civil defence purposes.
3. Nothing in Article 1 of this Order shall render it unlawful to cause or permit a disabled persons vehicle which displays in the relevant position a disabled persons badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the Schedule to this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
4. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under other enactment.
5. This Order may be cited as "THE KENT COUNTY COUNCIL (Various Roads, Maidstone) (Waiting Restrictions and Street Parking Places) Order 2012" and shall come into operation on the 20th day of June 2012.

Schedule
(Waiting Restriction and Street Parking Places)

| Road | Parish/Town | Length of Restriction |
|---|----------------|--|
| Becksbourne Close | Maidstone | On both sides from a point 24metres north from its junction with Sandling Lane to a point 65metres north from its junction with Sandling Lane. |
| Cuckoowood Avenue | Maidstone | On both sides from its junction with Sandling Lane in a north easterly direction to its junction with Sandbourne Drive. |
| A274 North Street junction with Southways | Sutton Valence | From a point 10metres northeast of its junction with Southways to a point 10metres southwest of its junction with Southways. |
| Sandling Lane junction with Cuckoowood Avenue | Maidstone | From a point 10metres northwest of its junction with Cuckoowood Avenue to a point 10metres southeast of its junction with Cuckoowood Avenue. |
| Southways | Sutton Valence | Both sides from a point 17metres west of its junction with A274 North Street to its junction with A274 North Street. |
