- 1.3.2 The Hackney Carriage Association have been consulted over the High Street project and following that consultation, at which they felt their views were well received, they do not wish to push for the reintroduction of the bays particularly as they would cost £3000.
- 1.3.3 In respect of the relocation of the camera in King Street to a location on the new council building the Association have been informed that the cost of the change could be in the region of £5000 and any change would be subject to planning permission and the agreement of the Mall. There is no resource within the budgets to pay for this change and with no guarantee that it could go ahead. If the Association would

wish to push ahead with this idea, the option available to the Council would be to seek the Association to pay for the changes.
