URGENT REPORT OF THE COBTREE OFFICER

1. <u>COBTREE MANOR PARK - MASTER PLAN</u>

- 1.1 Reason for the Urgency
- 1.1.1 In seeking the agreement of the Cobtree Charity Trust Limited to the draft proposals plan as agreed at the last meeting, this delayed the start of the consultation period. To allow a sufficient time for the consultation resulted in the closing date falling after the distribution of the initial agenda for this meeting. However, final instruction to the consultant is required before the next meeting of the Committee.
- 1.2 Issue for Decision
- 1.2.1 To consider the results from the public consultation exercise and to give final instruction to the appointed consultant.
- 1.3 Recommendation of the Cobtree Officer
- 1.3.1 It is recommended that Members endorse the draft master plan with the following amendments:
 - (i) Deletion of the proposed overspill car parking area, and investigation of appropriate improvements to the existing car parking area and surfacing,
 - (ii) Deletion of the cycle route and deferred consideration of the fitness trail until the need has been proven,
 - (iii) Incorporation of the Dog Agility area in a linear form rather than the present concentrated area,
 - (iv) Noting of the concerns expressed about existing maintenance standards, particularly for the existing pond, and to continue to support the current general

improvements to the park,

- (v) The inclusion of a more interesting play area catering for a wider age range of children,
- (vi) That officers be instructed to investigate further the feasibility of providing the proposed new lake,
- (vii) The inclusion of suggestions for the North West corner of the site; for the Animal Cemetery; and for a tree top walk, and
- 1.3.2 It is further recommended that officers be authorised to approach the Charity Commission, in liaison with the Cobtree Charity Trust Limited, to seek approval to the use part of the Charity's Permanent Endowment Fund to implement the enhancements set out in the agreed master plan.

1.4 Reasons for Recommendation

- 1.4.1 At the meeting of the Committee on 26 February 2010 Members received a presentation from the appointed consultant and endorsed the draft master plan for use in public consultation.
- 1.4.2 Members further agreed the format for the consultation exercise with a request that it be well advertised and good use made of the Council's website, the press and perhaps having a stand in The Mall Chequers, as well as the Gateway and Cobtree Manor Park itself.
- 1.4.3 Members were advised that although the proposals shown in the draft plan were broadly in line with the requirements set out in the initial brief, one area where the plan did not achieve this fully related to the children's play area; which was not "significantly different from similar facilities found in the area."
- 1.4.4 Members did make a number of additional comments about the submitted plan, but felt that many of these would be repeated during the consultation exercise.
- 1.4.5 Where Members did feel that further consideration might be warranted was in the following areas:
 - (i) The northwest corner of the site (shown on sheet CPO6) where the bridle path is not shown to link with the path which goes around the perimeter of the golf course.

- (ii) The animal cemetery (the site of which is shown on sheet CPO2) no proposals were indicated for this area.
- (iii) The possibility of a "tree top walk" which was a suggestion by previous consultants; this was not shown.
- (iv) Reference to the previous use of the site as a zoo; there appears to be no reference, but this may be covered in the proposed information boards; and this needed to be confirmed.
- 1.4.6 Members also resolved that views of the Trustees to the Cobtree Charity Trust Limited should be sought prior to the public consultation being initiated. The Trustees made a number of comments which they wished to see incorporated into the master plan before it was released to the public. However, by way of a compromise, it was agreed that the plan be released on condition that the comments of the Trustees be published at the same time, and that it be made clear that the inclusion of the lake proposal was subject to a further technical feasibility study.
- 1.4.7 The consultation period was announced through a press release published on Friday 19th March with a closing date for return of responses of Friday 16th April 2010.
- 1.4.8 In seeking responses from the general public and other interested parties an attempt was made to identify an order of desired priority. A copy of the consultation questionnaire is attached at **Appendix A** for information.
- 1.4.9 The response from the Cobtree Charity Trust limited is attached at **Appendix B**. A summary of the questionnaire responses received is attached at **Appendix C**.

1.5 <u>Consultation Results</u>

- 1.5.1 From the 85 responses received there appears to be general acceptance of the proposals shown in the draft plan. The most support is given to the proposals for specimen trees and improvements to the woodland area. Strong support is also given to pathway improvements and the proposed new café. The least support is given to the provision of the dog agility area and teaching areas.
- 1.5.2 Only 53 of the respondents gave a priority order for their top three choices; those that did indicated that the provision of a new café and a children's play area were the most popular

proposals, with the new lake and pathways also featuring highly.

- 1.5.3 As Members might expect, the comments from individuals varies enormously; with each wishing to protect their particular interest. The most significant number of replies came from existing park users whose primary interests lie in dog walking and use of the existing café provision. It is not surprising that the comments strongly reflect maintenance of the status quo.
- 1.5.4 There appears to be a general consensus that there is little need for overspill car parking which will most likely be necessary only during the summer months and could, therefore, be accommodated on the grassed areas. As a consequence it is recommended that the overspill car parking area be deleted from the master plan and that the existing car park be improved and re-surfaced.
- 1.5.5 Neither the cycle route nor the fitness trail featured highly among the most desirable elements within the proposal. It is not sure if the respondents appreciated the style of cycle route intended as the proposed route includes some very steep gradients and will only be suitable for experienced riders; this being the case, it is a comparatively short circuit which may not attract much interest. Of further concern is that in places it is very close to walking paths following a decent down a steep incline. It is recommended that the cycle route be deleted from the master plan, and that the fitness trail be subject to further investigation to prove a need.
- 1.5.6 Concern has been expressed by the Council's Senior Warden whose responsibilities include the control of dogs; he suggests that it would be inappropriate to congregate a number of strange dogs in the confined area proposed for the Dog Agility facility. It is recommended that the Dog Agility facility be provided in a linear form elsewhere in the park.
- 1.5.7 The concept of a children's play area received strong support from those consulted. Members desired a form of play area not found locally. It is recommended that the consultant be requested to bring forward suggestions for a larger more interesting play area catering for a wider age range of children.
- 1.5.8 There are reservations about the provision of a new lake, but it is considered by many to be a desirable feature to include. It is recommended that Members instruct further investigation into the feasibility of this element.

| 1.5.9 | Members expressed a number of concerns which have not been commented on in the consultation. It is recommended that Members confirm their comments from the previous meeting: namely that the consultant bring forward suggestions for the North West corner of the site; bring forward proposals for the Animal Cemetery; and bring forward proposals for the inclusion of a tree top walk. |

| 1.7 | Once the master plan has been agreed it was always the intention of the Charity to approach the Charity Commission, in liaison with the Cobtree charity Trust Limited, to seek consent to use part of the monies held in the Permanent Endowment Fund to help implement the proposed enhancements. It is requested that Officers be granted authority to make that approach to the Charity Commission. |
| 1.8 | Alternative Action and why not Recommended |
| 1.8.1 | The alternative course of action is to reconsider the basic proposals contained in the master plan. This is not recommended as the process to arrive at the existing proposals has been thorough and extensive. |
| 1.9 | Impact on Charity Objects |
| 1.9.1 | The intention of the master plan is to identify a number of enhancements to increase the attractiveness of the Cobtree Manor Park and thus better meet the objects of the Charity through greater public benefit. |
| 1.10 | Risk Management |
| 1.10.1 | Each individual enhancement will be risk assessed prior and during implementation. The greatest risk to the Charity is that the enhancements, once completed, do not have the desired effect of increasing visitor numbers. |

RESPONSE BY THE TRUSTEES OF THE COBTREE CHARITY TRUST LIMITED TO THE COBTREE MANOR PARK MASTERPLAN PROPOSAL BY ADAM BAILEY

The Trustees are grateful for the opportunity afforded by the Cobtree Manor Estate Charity committee to comment on the proposals for the master plan for the Park drawn up by Adam Bailey, the landscape contractor retained by Maidstone Borough Council. There is general acceptance of the majority of the ideas contained in the proposal, but particular comments are given below.

1. New pathway network

Agreed, but the horse bridleway should be renovated but left on its present route so as not to damage other routes. The bike trail should be enlarged and improved to pass through the woodland area and should cover a complete circuit around the Park and back to the starting point at the café. It would not prove sufficiently attractive to potential users as currently envisaged.

2. New café and exhibition space

Agreed. However, the outdoor café seating needs to be improved. The Mote Park café area is cited as an unattractive example of not being well designed. It is noted that no cost of building is contained within the plan; perhaps a figure is excess of £250,000 is required.

3. Increased car park facilities

Not thought necessary at this stage to provide for an overflow car park, though the area suggested should be earmarked for parking expansion in due course.

4. New play areas and fitness activities

New play areas should become the major attraction in the Park; the areas suggested seem too small. A larger and very exciting play area is suggested which would become the best in the area and on its own account attract great interest. In addition to a trim trail for adults, provision should be made for the fitness and wellbeing of the elderly and physically less able.

5. New lake and circulatory walk

Not agreed, as there is no natural source of water for this and it would only attract vermin and scavenging water birds. The ongoing cost of cleaning, etc

would be prohibitive, and the lake may well dry out in summer leaving a muddy and dangerous area.

6. Enhanced teaching areas

Agreed, though the cost of provision of the proposed facilities in the Elephant House seems excessive.

7. Dog agility area

Agreed only if the public survey feels this is appropriate.

8. Viewing platform

Agreed.

9. Improved enjoyment of the woodland and arboretum

Agreed.

10. Key signage

Agreed.

Further points


Concern was expressed with the lack of safety and security topics in the proposals. It was felt that this may add substantially to the ongoing costs of running the Park.

The Trustees suggest a link between the Park and the Museum of Kent Life to provide greater entertainment for families (especially) on days out. Perhaps this could take the form of tractor pulled wagons between the sites.

There is no present intention within the plan of proceeding with the hoped for railway; therefore the need to attract visitors with another 'pulling point', such as a greatly improved play area, is essential. The Park's benefactors were both keen animal lovers, so perhaps future plans could include the provision of an aviary bringing more exotic species of birds to the attention of visitors.



You are going to spoil a thing of natural beauty with play areas and goodness knows what; you will cause further damage to nature.

Too much clearance has been done in the park and it will badly affect the wildlife. The clearance by the Old Metal Gates may be detrimental to the Tuberous Comfrey growing there. The re-routed bridle path will damage the habitat of great crested newts in the pond. Local Dog-Walking Area badly placed on steep slope with badger or fox habitation (the plans mis-interpreted). Lake near the cafe will bring flies; consider making a lake on the main drainage ditch. No access to Cycle Path for ambulances. Contain the children and keep the area beyond the metal gates for restful walking and people in wheelchairs.

From letters from park users:

With more car parking and visitors the park will loose its peacefulness. The park should be kept as open space and woodland, to enjoy peace and quiet; extra parking and cycle routes will take it away. Cobtree was left to local people to enjoy and we have already lost a large amount of it to a golf course.

Much clearance has already been done in the woodland with little regard for wildlife: small mammals, hibernating insects etc. The badger sett has had some clearance (*not correct-Eva*). All this has made the park noisy from road traffic, cold and windy. The cycle path will bring even more destruction as youngsters ride through the park to reach allocated area.

Comments from other interested parties

Medway Valley Countryside Partnership:

Provide access on footpaths and off footpaths for different levels of experience.

Café and exhibition space agreed - provide interpretation in this area.

Increased parking agreed if sympathetic to the site.

Play area agreed - consider equipment similar to that at Manor Park (KCC).

Fitness trail - only if the need confirmed; mixed success in other country parks.

No' to the lake - likely maintenance problems, the park has many equally good habitats; consider improving the parkland pond for wildlife and for education (a dipping platform).

Enhanced teaching areas agreed.

Dog agility area - only if the need confirmed; consider moving further away from the Elephant House and the bridleway (conflict of interests).

No objection to the removal of the Leylandii hedge - low wildlife value; the loss can be mitigated by allowing more scrub to remain.

Use of Elephant House agreed but investigate the possible presence of bats.

Meadow planting agreed but low nutrient levels in soil must be maintained.

Woodland sculptures agreed if local artists and materials are used.

Cycle route - too short for serious cyclists; may put families off visiting the woodland if they expect larger bikes

Give high priority to the safety and security of the site.

Ensure that the park's high value in terms of wildlife and educational potential is retained.

Include references to wildlife in the interpretation material. Provide interpretation panels.

Include 'footprints' of native species e.g. badgers.

Consider re-introducing heath land plants - gorse, broom, heather.

Consider a more relaxed mowing regime to encourage native flora and fauna.

Kent Wildlife Trust:

The proposals make practically no references to the wildlife value of the site, which is likely to be considerable. Any enhancements to the park should be based on appropriate ecological assessments such as species surveys and surveys to establish presence of protected species. The felling and chipping of trees as described could reduce the available insect habitat and could theoretically disturb roosting bats.

We would welcome enhancements that would enrich biodiversity and strengthen linkages with other important habitats in the local area.

The British Horse Society:

The bridle path must be continuous through the park, on the plan it seems to have ends (designer's mistake) Park visitors seem to enjoy seeing horses; occasional conflicts with other users are usually due to unruly dogs.

Consider moving Trim Trail feature TT7 away from the bridle path as unusual movements may startle some horses.

Hardwood mulch must be laid on well drained ground; otherwise it turns to soft mud.

Mr and Mrs Wyatt, Cobtree Cabin:

A strong objection to the proposal to build a large catering building and the introduction of the catering style that this would require; this would change and ruin the existing business. There is no need to build a new high status cafeteria at considerable cost. With some additional space (larger kitchen, some indoor seating) the existing business could easily cater for the increased visitor numbers in what is basically a sound and pleasant looking building.

Eva Girling, Cobtree Park Ranger, MBC:

Car parking - currently no need for overflow parking but earmark an area for the future; existing car park is in need of resurfacing and cars should be prevented from driving into the shrubberies; existing knee rail needs replacing.

Paths and trails - provide a medium-length suitably surfaced circular route accessible to wheelchairs (consult local disability access advisors); consider installing steps up banks on popular desire lines where ground becomes very slippery in winter. Reduce the number of hard paths between the cafeteria and the woodland. Reconsider the need for a hard path from the Llama House northwards - the ground drains well there and mown grass paths may be sufficient.

New Café etc - consider moving the outdoor seating north of the building for better screening from traffic noise. Provide a garage and good access for the utility vehicle as well as staff office/mess-room; or relocate staff to the Elephant House.

Arboretum etc - consider reducing the size of animal footprints from 1 metre across.

Woodland routes and sculpture - the cycle circuit seems rather short for serious cyclists and on the lower part the cyclists will be in conflict with walkers and dogs; it will cause damage to the woodland and may invite motorcycles; it is too steep in places to be used by smaller children. The sculptures may become vandalised; consider creating a woodland sensory trail instead.

The lake - there are many possible problems and disadvantages so carry out a comprehensive feasibility study before embarking on this project.

Elephant House and teaching areas - consider reducing the number of seating areas in this part of the park from three to two; consider the building for staff use as well for school parties in bad weather.

Bridle path - consider removing the link to the car park altogether, or running it up the Hornbeam Avenue.

Play area - consider moving it further uphill but ensure coverage by the CCTV camera.

Dog agility area - distribute the equipment along a dog walking circuit on the Elephant Hill.

Viewing platform - agreed.

Trim trail - confirm the need, provide more interesting, unusual equipment, suitable for children as well as adults (if possible).

Jeff Pedrick, Senior Warden, MBC:

The council are looking to reduce the numbers of dog-litter bins rather than installing more, because of the cost of emptying them.

Dog agility equipment would be better placed along a route to stop strange dogs congregating in one place; possible H&S problems: loose dogs, dog fights, conflicts with children.

Dog paths can become smelly in summer but there are solutions to this problem.

An aviary would require a license and staff.

Vronni Ward, Public Relations Officer, MBC:

Convert the Elephant House to use by local artists (The Scarlet Pimpernel Art Collective) as a space for exhibitions and workshops for the community, and providing income. The Scarlet Pimpernels have received a Lottery grant for projects within the community and are actively looking for a suitable venue.
