#### 1. STREET TRADING CONSENT- MR GREENFIELD

#### 1.1 Issue for Decision

1.1.1 To consider the Street Trading Consent for the sale of Christmas wrapping paper, sticky tape, gift tags and Christmas cards issued to Mr. Greenfield on 22 February 2011in respect of Ethos, 9 Gabriels Hill, Maidstone, Kent, in order to clarify the committees view of the exact location for which the consent was granted.

#### 1.2 Reason for Urgency

1.2.1 The issue of the location of Mr. Greenfields stall under his Street Trading consent has only arisen since the agenda had been issued and his consent will terminate on 31 December 2011 which is before the next meeting of the Committee.

### 1.3 Recommendation of the Head of Democratic Services


1.3.1 That the Committee give consideration to the report and give clarification to the exact location of Mr. Greenfields stall under the consent granted by the Committee at its meeting on 17 February 2011.

# 1.4 Reasons for Recommendation

1.4.1 The Committee at its meeting on 17 February 2011 gave Street Trading consent to Mr. Greenfield for the sale of Christmas wrapping paper, sticky tape, gift tags and Christmas cards only, for the period of 1 November 2011 to 31 December 2011 daily from 9am to 6pm on the Ethos courtyard, 9 Gabriels Hill, Maidstone. Attached at Appendix A is the Street Trading consent granted to Mr. Greenfield indicating that he was allowed to trade from the Ethos courtyard. A copy of the application and plan Mr. Greenfield submitted indicating the proposed location of his stall is attached as Appendix B to the report. This plan

was attached to the report submitted to the committee on 17 February 2011.

- 1.4.2 Subsequent to this consent having been granted to Mr. Greenfield, Ethos has closed and has not been re-opened, leaving the courtyard area closed off by the current owners of the site. Mr. Greenfield considered that his Street Trading consent allowed him to trade from in front of the gate to Ethos and he recently started trading from that site. The Environmental Enforcement team queried this position with the Licensing team who indicated that his consent was for the courtyard and as such Mr. Greenfield should not be able to trade from in front of the gate to the Ethos courtyard. Mr Greenfield challenged this and having considered his plan and following discussions with other Officers within the Council, it is felt that perhaps Mr. Greenfields plan was not clear in terms of the precise location of where he wished to trade. Mr. Greenfield has received permission from the landowners to trade on their land and their land is not just the courtyard but also the area of land in front of the gate right up to the footpath forming part of the public highway. Attached at Appendix C is a copy of a GIS Plan which shows this site in greater detail. However, this does not clarify the position to any great extent and therefore I am asking Members to assist by clarifying their interpretation, of what was agreed in terms of the location of Mr. Greenfields stall. Namely should he be within the courtyard of Ethos behind the current gates or outside the gates in a position halfway along the wall of the adjoining premises of Head and Heart.

- 1. the Consent holder must ensure that he/she comply strictly with all traffic regulations;
- 2. the Consent holder will ensure that his/her street trading activities do not create any obstruction to the flow of pedestrians or other traffic using the street or part of the street to which his/her Consent relates, nor creates any danger to persons using it;
- 3. the Consent holder will ensure that his/her street trading activities do not cause any nuisance or annoyance, whether to persons using the street or part of the street to which his/her Consent relates or otherwise;
- 4. no signs advertising the trade are placed on the highway (or abutting the highway);
- 5. the Consent form must be available for inspection at all times during the hours of trading at the place of trading;
- 6. a Consent number is displayed in an appropriate place;
- 7. the Consent holder will ensure that his/her vehicle is removed from the site at the end of each working day;

- 8. the Consent holder will not deposit trade refuse or litter of any kind on the street or part of the street to which his/her Consent relates;
- 9. the Consent excludes Maidstone Carnival Day, the day of the River Festival and any other special events;
- 10. the Consent holder will ensure that permission has been obtained for the use of land adjacent to the highway from the landowner and adjoining landowners when appropriate. The granting of a Consent does not imply that landowner permission has been granted;
- 11. Consent to trade in a certain location does not imply the grant of planning permission and applicants are strongly recommended to consult the Director of Development Services prior to commencement of trading;
- where food is sold, the Consent holder must comply at all times with ALL current hygiene legislation including EU hygiene regulations and the Food Hygiene (England) Regulations 2006, as applicable.

The Council may at any time vary the conditions of a Street Trading Consent and may revoke the Consent at any time.

The holder of a Street Trading Consent may at any time surrender his Consent to the Council and it shall then cease to be valid.
