PROVIDE A SAFE TOWN CENTRE: A Space to Feel Safe

Why is this important?

Maidstone is the County Town of Kent hosting one of the largest retail centres in the southeast. It has excellent rail and road networks to London and the County. Many of our residents utilise the town for retail, leisure and work. As a transportation hub the Town Centre also welcomes large numbers of commuters and children travelling to and from school. It also hosts a large night-time economy that brings its own challenges and rewards. The town benefits from a Business Improvement District, One Maidstone, which provides the MaidSafe radio network and works in partnership with the police, local authorities and local businesses to reduce crime, increase trade and make Maidstone a safer environment for its staff, customers and visitors.

Recent surveys highlight that both adults and young people feel the Town Centre at times is unsafe. A minority of isolated but unacceptable incidents have further tarnished the Town's reputation. Analysis shows that there are hotspots within the Town Centre where violent crime and ASB is most prevalent.

We must remain realistic to the fact that the Town Centre attracts a variety of people and as a result, there will be occasional incidents.

What is the SMP's Objective?

The SMP will work to restore the reputation of the town as a place where people feel safe and are safe.

What is our focus?

SMP Partners will:

- develop a multi-agency task force to address concerns, such as:
 - o anti-social behaviour
 - o violence, particularly in the night-time economy
 - substance misuse and illegal supply of drugs and alcohol, particularly to children
 - vulnerable people who live in the town, including domestic abuse
- ensure businesses develop a culture in the town that keeps people safe in both day-time and night-time economies
- protect young people by challenging behaviour and ensuring safeguarding opportunities are provided for those in need of support
- work to improve the reputation of the town by sharing successes and publicising initiatives that make people feel safe when in the town

What will we do?

The SMP will bring together statutory and non-statutory partners to form a dedicated Town Centre Task Force to develop a new multi-agency strategy.


A safe place to go at night


The Riverside



- In total there are 11 comments from residents related to the River Medway.
- Main points that were addressed:
- increasing the number of cafes, theatres and bars nearby. Also, introducing activities near the river, such as kayaking, row boats and paddleboarding.
- Enhance street scenery by the river- 3 comments stated that more attractive buildings should be placed by the river, rather than the Travel Lodge.
- Also increase access to the river by adding in a secure footbridge to cross the A229 from Fremlin Walk to the other side.
- 1 comment suggested adding barriers near the river for safety purposes.

In total, there are 3 comments related to Maidstone East.

Main themes include:

making trains more reliable and affordable.

Delivering faster trains to London, particularly the finance areas such as cannon street and London Bridge to attract businesses.


Increasing the safety of the path between Maidstone Barracks and Maidstone East.

Support local restaurants, rather than bringing in more fast food chains.


Cleaner buildings to make it more attractive.

Vacant Retail Units



- Between 2016- 2021 the percentage of vacant retail units in the town centre has increased year on year.
- The 2020/21 figure of 18% is the highest it has been since we began recording this data.
- Jan- July 2022 the figure improved to 16%
- In 2019 there were 4 vacant units in Lockmeadow, there is currently only 1

Unsafe Places

Survey respondents were provided with a free text box and were asked to tell us about any areas in the borough where they feel unsafe.

The most common place where respondents said they felt unsafe was the town centre. The top twelve response are shown.

There were 638 comments that gave a location (many respondents mentioned more than one location).

Overall, almost three in five respondents to this question mentioned the town centre as a place in Maidstone that they feel unsafe.








Incidents of Crime in the High Street

January- December 2021:



• Crime (VAWG, Neighbourhood and NTE) accounts for 14% (2017-19) and 10% (2021) of the borough's crimes in these categories. It also accounts for 15% (2017-19) and 11% (2021) of the boroughs ASB.

• In 2021, a Youth Safety Survey and a Community Safety Survey both highlighted the Town Centre as an area where fear of crime if very prevalent, with Brenchley Gardens and the area of Week Street by KFC and McDonalds, both within 004F highlighted as "no go areas" due to the behaviour and criminality associated with them . 78% of respondents to the Community Safety Survey feel that the Town Centre is unsafe or very unsafe at night.



Comments from Town Centre PSPO 2020 about visiting the Town Centre

The town should be improved for all people. It has a feeling of withering on the vine.

I hardly go up to Maidstone town centre any more due to the cost of parking and the constant traffic congestion, If we do need to go to shops we generally go up to Blue Water where it's free parking and everything is under cover

Jubilee Square has become the place the drug addicts and drunks frequent, this area is intimidating when children are present

I live almost half way between Ashford and Maidstone (even though under MBC. Would rather visit and do use High Street and facilities there rather than use Ashford!



Reason for Review

At its previous meeting the committee agreed to conduct a review into the topics, with the aspects of safety relating to the town centre and the night-time economy.

A suggestion to review enforcement was also put forward by the Executive, with the Lead Member for Environmental Services in attendance indicating Committee input into the resourcing of enforcement would be welcomed.
